("CYPRIUM") PAID CASH DISTRIBUTIONS TO ITS 9.375% SERIES A CUMULATIVE REDEEMABLE PERPETUAL PREFERRED STOCK ("SERIES A PREFERRED STOCK") SHAREHOLDERS.

SHAREHOLDERS WHO WERE HOLDERS OF SERIES A PREFERRED STOCK AS OF THE CLOSE OF BUSINESS ON SEPTEMBER 15, 2020, THE RECORD DATE, WERE ELIGIBLE TO RECEIVE CASH DISTRIBUTIONS OF \$0.1953125 FOR EVERY SHARE HELD.

CYPRIUM DOES NOT HAVE ACCUMULATED EARNINGS AND PROFITS ("AE&P") AS OF JANUARY 1, 2020 AND DOES NOT BELIEVE IT WILL HAVE CURRENT YEAR E&P ("CE&P") AS OF SEPTEMBER 30, 2020. 2020 CE&P CANNOT BE FINALLY DETERMINED UNTIL THE 2020 TAX YEAR IS CLOSED.
