("CYPRIUM") PAID CASH DISTRIBUTIONS TO ITS 9.375% SERIES A CUMULATIVE REDEEMABLE PERPETUAL PREFERRED STOCK ("SERIES A PREFERRED STOCK") SHAREHOLDERS. SHAREHOLDERS WHO WERE HOLDERS OF SERIES A PREFERRED STOCK AS OF THE CLOSE OF BUSINESS ON JANUARY 15, 2025, FEBRUARY 15, 2025, AND MARCH 15, 2025, RESPECTIVELY, THE RECORD DATES, WERE ELIGIBLE TO RECEIVE CASH DISTRIBUTIONS OF \$0.1953125 FOR EVERY SHARE HELD.

CYPRIUM DOES NOT HAVE ACCUMULATED EARNINGS AND PROFITS ("AE&P") AS OF JANUARY 1, 2025 AND DOES NOT BELIEVE IT WILL HAVE CURRENT YEAR E&P ("CE&P") BASED ON THE LATEST FINANCIALS AVAILABLE. HOWEVER, 2025 CE&P CANNOT BE FINALLY DETERMINED UNTIL THE 2025 TAX YEAR IS CLOSED. IF CYPRIUM LATER DETERMINES THAT IT HAS 2025 CE&P, CYPRIUM WILL FILE A CORRECTED FORM 8937.
